Selection of board members will be made by a selection committee comprised of a representative of People First of Louisiana (PF of LA), the executive director PF of LA, the executive director of The Arc of Louisiana, a representative of the Louisiana Developmental Disabilities Council, and a representative of a disability or advocacy organization. One representative will be selected from each region. In addition, two (2) "at-large" representatives will be selected. These two at-large representatives may reside anywhere in the state of Louisiana and will represent the state at-large."

- *Candidates for the Board of Directors will complete and submit an application. Selection of board members will be made by a selection committee comprised of a representative of People First of Louisiana (PF of LA), the executive director PF of LA, the executive director of The Arc of Louisiana, a representative of the Louisiana Developmental Disabilities Council, and a representative of a disability or advocacy organization. If the vacancy results in a member completing less than one half of the current term, it does not count as a term when figuring term limits. That member may serve two (2) complete terms.

If the vacancy results in a member completing more than one half of the current term, it does count as a term when figuring term limits. That member may complete the current term and serve an additional (one) term."

If the vacancy results in a member completing less than one half of the current term, it does not count as a term when figuring term limits. That member may serve two (2) complete terms.

If the vacancy results in a member completing more than one half of the current term, it does count as a term when figuring term limits. That member may complete the current term and serve an additional (one) term.
